2-student teams carry out their own scientific (emprirical) analysis, which is usually based on a **current research paper from a leading international journal** specified by the chair.

This gives students a deeper insight into current practical and theoretical issues in finance, banking and capital markets.

In addition, content-related and other methodological basics are taught that are indispensable for the preparation of a **Master's thesis** in Finance and Banking.



Selection of Participants

If the seminar is "overbooked", participants will unfortunately have to be selected. This will be done on the basis of progress and previous performance in finance and statistics.

Grading

Seminar paper (60%), presentation (30%) + discussion (10%)

Seminar Thesis

45,000 to 50,000 characters per team of 2 (for details see chair's guidelines for the preparation of seminar papers)

Presentation

About 75 min + 30 min discussion

Each participant takes part in all sessions.
